COUNTY:

Road Millage: 1 mill (\$1.00 per \$1,000 of taxable value) for four (4) years 2022-2025, funding for maintenance, repair, and resurfacing of roads, major and local streets.

Renewal of Senior Millage: .05 mill (\$.50 per \$1,000 of taxable value) for a period of four (4) years, 2022 through 2025, funding for senior citizens services

Emergency Services Millage Proposal: .05 mill (\$.50 per \$1,000 of taxable value) for a period of four (4) years, 2022 through 2025, funding to cover its share of the operation, capital improvements, and equipment of the CCE 911 Central Dispatch Authority, for the operation, capital improvements, and equipment of the Cheboygan County Sheriff's Office of Emergency Management; and for the purchase of vehicles and equipment for the Cheboygan County Sheriff's Department.

BURT: Fire Protection Millage – .05 mill (\$0.50 per \$1,000 of taxable value) for two (2) years 2022-2023, funding for Township fire protection. FOREST: Renewal of Fire Protection Millage - 1 mill (\$1.00 per \$1,000 of taxable value) for four (4) years 2023-2026, funding for Township fire protection. KOEHLER: Renewal of Fire Protection Millage - 2 mills (\$2.00 per \$1,000 of taxable value) for six (6) years 2023-2028, funding for Township fire protection. NUNDA: Renewal of Road Maintenance Improvement and Upgrading Millage - 1.25 mills (\$1.25 per \$1,000 of taxable value) for four (4) years 2023-2026, funding for road maintenance, improvement, upgrading, and other road related expenses.

SCHOOLS:

INLAND LAKES SCHOOL PROPOSAL: Operating Millage Proposal – be renewed by 17.8956 mills (\$17.8956 on each \$1,000 of taxable valuation) for a period four (4) years, 2023-2026, inclusive, and also be increased by .05 mill (\$0.50 on each \$1,000 of taxable valuation) for a period of five (5) years 2022-2026, inclusive to provide funds for operating purposes.
